Conditions of Season Ticket

- The season ticket is for Billingford Lakes Limited, located at North Elmham Road, Billingford, Dereham, Norfolk, NR20 4RF.
- Season ticket holders can fish a maximum of 72 hours in each session.
- Persons wishing to hold a season ticket at Billingford Lakes Limited shall complete the official application form. Applicants are required to submit the form duly completed to the Fishing Bailiff. Each application form must be accompanied by full payment of the annual fee.
- Absolute discretion is granted to Billingford Lakes Limited to reject any application or renewal
 without ascribing any reason for doing so; in such cases any monies paid will be immediately
 refunded.
- On acceptance of an application, the applicant will be sent a season ticket card, which will remain property of Billingford Lakes and upon termination of the season ticket for whatever reason, will be returned to the Billingford Lakes.
- Season ticket holders must carry their season ticket card at all times while on site and produce a card if asked.
- The Season ticket for Billingford Lakes is a contract, which runs for a 12-month period from joining. After the said 12-month period has been met by applicants the season ticket can be renewed for a further 12-month period. The winter ticket is for a 6 months period. Any cancellation before you have fulfilled your required 12/6-month contract would require written confirmation and no refund is available.
- Billingford Lakes can make changes to the season ticket at renewal.
- A season ticket for Billingford Lakes shall commence on the day of application acceptance.
- Season tickets can be renewed annually by payment to Billingford Lakes Limited of the annual subscription due on or before the expiry date shown on the Season Ticket. Billingford Lakes may refuse to renew the Season Ticket of any fisherman without giving any reason.
- A season ticket is not transferable.
- The times at which any or all of the facilities are available to season ticket holders and guests shall be at the discretion of Billingford Lakes. Any or all of the facilities may be closed at any time due to weather conditions or for the purpose of restocking, maintenance or competitions.
- Billingford Lakes Limited accepts no liability for any injury or illness resulting from the use of the facilities by season ticket holders or guests howsoever caused.
- Season ticket holders are responsible for their personal possessions including fishing equipment and vehicles on site.
- Billingford Lakes Limited shall have the power and the right at any time and upon one month's notice
 to a Season ticket holder to discontinue the ticket upon refunding to season ticket holders the
 unexpired portion of their current season ticket.
- Season ticket holders accept and agree to be bound by the rules of Billingford Lakes. Billingford Lakes in its sole discretion may at any time vary these rules or season ticket subscription or any of the charges for use of any or all of the facilities.
